# ফ্রান্সকে সতর্ক করলেন লিজারাজু

প্যারিস, ৬ জুলাই: ফ্রান্স বড্ড বেশি নির্ভরশীল হয়ে উঠছে পল পোগবার ওপরে। জার্মানির বিরুদ্ধে সেমিফাইনালে নামার আগে দিদিয়ের দেশের দলকে সতর্ক করে দিলেন প্রাক্তন ফুটবলার বিসেস্তে লিজারাজু।

সমর্থক ও মিডিয়া যে ভাবে পোগবার ফর্ম কাটাচ্ছে তা করায় বাস্তব, তা পছন্দ নয় ফ্রান্সের প্রাক্তন লেফট-ব্যাকের। ২৩ বছর বয়সি পোগবা যদিও শেষ আটে আইসল্যান্ডের বিরুদ্ধে হেডে দলের প্রথম গোল করেছিলেন। ১৯৯৮ বিশ্বকাপ ও ২০০০ ইউরো কাপ জয়ী ফ্রান্স দলের অন্যতম সদস্য লিজারাজু বলেছেন, 'পোগবার প্রতিভা নিয়ে কোনও কথা হবে না। ও অবিশ্বাস্য প্রতিভার অধিকারী। টেকনিক্যাল দক্ষতা থেকে শারীরিক শক্তি, দুই রয়েছে ওঁর। সমস্যা হল, আমরা ওঁর থেকে বড্ড বেশি প্রত্যাশা করছি। সবসময় ওঁকে সর্বোচ্চ পর্যায়ে দেখতে চাইছি। সমস্যা হল, ওঁর বয়স বড্ড কম, মাত্র ২৩। এটা আমরা ভুলে যাচ্ছি। ফুটবলার হিসেবে উন্নতি করার চের সময় রয়েছে। চাপের সঙ্গে মানিয়ে নেওয়ার কাজটা সহজ নয় ওঁর পক্ষে। আর এই প্রতিযোগিতায় স্টেটাই বার বার চোখে পড়েছে।'

লিজারাজু অবশ্য প্রশংসা করেছেন আন্তোনিও গিঞ্জিয়ান ও দিমিত্রি পায়েরের। তিনি বলেছেন, 'মাঠে গিঞ্জিয়ানকে সবসময় শাস্ত দেখায়। বিশ্বকাপে ও ভালো খেললেও বিপক্ষ রক্ষণ ভাঙতে পারছিল না। এখানে তা করছে। ছয় মাস আগে পায়েরে আবার স্কোয়াডেই ছিল না। ও যা করেছে তা সেই কারণেই অবিশ্বাস্য লাগছে। বিশ্বমানের ফুটবল খেলছে ও।' অন্তত সেমিফাইনালে যাওয়ার লক্ষ্যপূরণ হয়েছে ফ্রান্সের, জানিয়ে দিয়েছেন তিনি। কিন্তু বিশ্বচ্যাম্পিয়ন জার্মানির বিরুদ্ধে মিডফিল্ড ও রক্ষণের মধ্যে যোগাযোগের অভাব বামেলায় ফেলতে পারে বলে আশঙ্কা তাঁর। লিজারাজু বলেছেন, 'যা আশা করা গিয়েছিল, ফ্রান্স সেখানেই উঠেছে। তবে এই সফরে যতটা মনে করা হয়েছিল, তার চেয়ে বেশি বামেলায় পড়তে হয়েছে। ভালো করতে গিয়ে খারাপ হওয়ার আশঙ্কা ভুগিয়েছে দলকে। সেমিফাইনালে খেলা ন্যূনতম চাহিদা ছিল ফ্রান্সের কাছে। ওরা সহজ গ্রুপে ছিল। তারপর সোজাসাপটা নকআউট ম্যাচ পেয়েছিল। এখনও পর্বস্ত ভুল করেও রেহাই পেয়েছে। কিন্তু ইউরোপিয়ান চ্যাম্পিয়নশিপের সেমিফাইনাল অন্য লড়াই। একবার ভুল করলেই বিদায় নিশ্চিত। আমরা যদিও উন্নতির রাস্তায় রয়েছি। ইক্সপে মিডফিল্ড ও রক্ষণের মধ্যে যোগাযোগের অভাব রয়েছে। যার সুযোগ বড় দল নিতেই পারে।'
