## 'Govt to focus on strategic stake sales to meet target'

New Delhi, July 3

THE GOVERNMENT WILL focus on strategic stake sales to meet the ₹1.20-lakh-crore CPSE disinvestment target in the current fiscal, Dipam secretary Tuhin Kanta Pandey said on Friday.

The government has already invited bids for strategic sale of national carrier Air India and oil major BPLCL. However, their bid deadlines have been extended amid the Covid-19 pandemic.

For BPLCL, in which the government is selling 52.98% stake, the deadline has been extended till July 31. For 100% stake sale in Air India, deadline for bid submission is now August 31.

Speaking at a webinar on Bharat Bond ETF, Pandey said the Department of Investment and Public Asset Management (Dipam) has minority stake sales of central public sector enterprises (CPSEs) on its table but

the emphasis is on strategic disinvestment. "Many of our strategic transactions are going on and moving forward. There was little bit of disruption due to Covid-19 and extensions given in terms of EoI but the government has clarified that we are very much on the same track of aggressively pursuing strategic disinvestment. More focus on that. Of course, there will be OFS (offer for sale), buybacks... (but) it will be more focused on strategic disinvestment," he said.

## PFC-REC loan amount for discoms may increase to ₹1.25 lakh crore

THE QUANTUM OF loan amount for state-run distribution companies (discoms) offered by the Centre may be raised to ₹1.25 lakh crore, from the ₹90,000 crore designated earlier, on the request of the states, Union power minister

RK Singh said. The Centre had announced the liquidity infusion scheme to clear the dues owed by discoms to the private and central government-owned power gencons till March, but several states, citing the discoms' additional stress

due to the coronavirus lockdown, want the loan to take care of their outstanding till June, the minister added.

Singh was addressing the

power ministers of the state governments through a video conference. A sum of ₹20,000 crore of loans from the scheme has been approved as of now.

The Centre and states also discussed the new scheme to revamp the discoms, which will subsume the existing central schemes for the electricity sec-

tor such as the Integrated Power Development Scheme (IPDS) and the Deen Dayal Upadhyaya Gram Jyoti Yojana (DDUJYA).

## রাজ্যের প্রাক্তন মন্ত্রীর বাড়িতে বিজেপির দুই বিধায়ক!

## কাটমানি ও কমিশন নেওয়ার অভিযোগ তৃণমূল পঞ্চায়েত সমিতির সভাপতিকে শো-কজ নোটিস

নিজস্ব প্রতিবেদন, মালদা: কাটমানি ও কমিশন নেওয়ার অভিযোগে শো-কজ করা হল কালিয়াচক ২ পঞ্চায়েত সমিতির সভাপতি টিকুর রহমান বিশ্বাসকে। দলের তরফ থেকে নোটিস দিয়ে দ্রুত ওই তৃণমূল নেতাকে জবাবদিহি করার নির্দেশ দিয়েছে দলের জেলা তৃণমূল নেতৃত্ব।

কালিয়াচক ২ পঞ্চায়েত সমিতির সম্প্রতি সভাপতি টিকুর রহমান বিশ্বাসের বিরুদ্ধে রাজ্য নেতৃত্বের কাছে বেশ কিছু অভিযোগ জমা পড়ে। সেই অভিযোগে উল্লেখ করা হয়, সরকারি প্রকল্পে কাজ পাইয়ে দেওয়ার নাম করে ওই তৃণমূল নেতা মোটা টাকা কমিশন নিয়েছে। এমনকী, বিভিন্ন জায়গায় থেকে কাটমানি তুলেছে। এই নিয়ে একদিকে রাজ্য নেতৃত্ব যেমন তদন্ত শুরু করেছে, তিকি তেমনি জেলা নেতৃত্ব তদন্ত প্রক্রিয়া চালানোর কাজ শুরু করেছে। এরপরই ওই তৃণমূল নেতাকে দলের জেলা নেতৃত্ব শোকজ নোটিশ পাঠিয়েছে।

দলীয় সূত্রে জানা গিয়েছে, গত ২৬ জুন ওই তৃণমূল নেতার বিরুদ্ধে দলের জেলা সভাপতি তথা রাজসভার সসেন সদস্য মৌসুম নূর এবং জেলার কো-অর্ডিনেটর অম্মান ভাদুড়ির স্বাক্ষর করা শো-কজ নোটিশ পাঠানো হয়েছে।

বিজেপির রাজ্য নেতা মানবেন্দ্র চক্রবর্তী বলেন, 'গোটা পশ্চিমবঙ্গ জুড়ে শো-কজ চলছে। আজকে আক্ষানের দুর্নীতিতে শো-কজ হচ্ছে। এটা কেবল মাত্র মানুষকে ধোকা দেওয়ার একটা চেষ্টা চলছে।' জেলা কংগ্রেসের সাধারণ সম্পাদক কালিসাধন রায় বলেন, 'শাসক দলের ওপর থেকে নিচু তলার সকলেই দুর্নীতিতে যুক্ত। পঞ্চায়েতের সমস্ত কাজে দুর্নীতি



চলছে। সাধারণ মানুষের সঙ্গে কাজের নামে ঠগবাজি ও প্রতারণা করা হচ্ছে।' সিপিএমের জেলা সাধারণ সম্পাদক অম্বর মিত্র বলেন, 'গোটা তৃণমূল দলটাকে শো-কজ করা উচিত। তৃণমূলের উপর থেকে নীচ পর্যন্ত দুর্নীতিতে ভরে গিয়েছে।'
